UK NARIC services for members: new developments for 2018

The new year 2018 sees a number of new developments now live or coming up in our services for members – in grades information, verification of qualifications, and broader, richer data on the suitability and preparedness of applicants.

The latest upgrades and extensions to our International Grade Comparisons (IGC) data bank are now live. IGC now covers 110 countries and 405 qualifications. Also new for 2018 is the ability to see and compare grades data from previous years. This allows for shifts or trends in grade distributions in a country over time to be seen.

IGC in 2018 also features a more granular analysis of overseas grades so that these can be more directly compared to A level grade combinations and entry thresholds.

The European Grade Distributions (EGD) database, which covers Europe only, is now presented in PDF format and is available via the Publications tab on the members' Hub. The Grades tab on the Hub accesses the extended IGC. If you do not currently have access to IGC and would like more information or a trial, contact members@naric.org.uk.

There is an increasing focus on fraud and the authentication of documents. This was discussed at our November conference and is also the subject of UK and global media attention, with UK NARIC recently briefing journalists about degree fraud for programmes on the BBC and Channel News Asia. Training in Leeds, London, Sheffield, Cheltenham

We are offering more half-day workshops in London on 13 and 14 March, covering key topics for education and recruitment: Evaluating International Qualifications, Combating Education Fraud, Understanding and Evaluating Professional Qualifications, and Education in India, Pakistan and Bangladesh. Candidates who have been educated in Lebanon or Saudi Arabia may offer admissions teams and employers the International Arab Baccalaureate (IAB). This qualification has now been benchmarked by UK NARIC and, from the first cohort of graduates for the updated qualification in 2017, it is considered comparable to the overall UK GCE A level standard.

This international diploma, which has been developed by the Educational Research Center (ERC) in Lebanon, runs alongside national upper secondary level qualifications (*Lebanon*, *pictured above*). The three-year IAB Diploma focuses on 4 science subjects (biology, chemistry, physics and maths) plus 2 languages (Arabic and either English or French). With the exception of English language, each STEM subject passed at over 60% is comparable to GCE AS level. This is because of the smaller volume of learning compared to a GCE A level in a single subject. (more...)

The TOEFL® Search Service is a web-based database that helps you find the right international students for your undergraduate, graduate and English-language programs. It provides current, targeted mailing lists of prospective students to support your recruitment efforts.

How can it help me?

The TOEFL Search Service gives you access to a database of over one million students from over 180 countries. So it allows you to not only focus on countries you need but also gives you the flexibility to broaden your search to include countries that you may not have looked at before. UK NARIC certificate bank updates live – 1000 images added, covers 50% more countries & territories

To give members more information to help them visually check documents offered to support an application, UK NARIC's Research and Data Group has been working hard to add to our bank of certificates and transcripts from around the world.

In the last year, 1068 high resolution images were added to the bank, increasing the number of countries/territories covered from 103 to 156. This means there are now a total of 4568 images covering 75% of the 206 countries in the UK NARIC International Comparisons database.

This upgrade makes the certificate bank an even more useful tool for fraud prevention and maintaining compliance with Tier 4 student visa requirements (more...)
