### Our Tier 4 compliance seminars now CPD and OISC accredited

UK NARIC's most popular seminar event, on Tier 4 compliance, is now CPD-accredited and OISC-accredited for immigration training, following a successful application by UK NARIC to the CPD Standards Office.

Our next scheduled Tier 4 compliance event is at the University of the West of Scotland Paisley campus on 28 October. UK NARIC is now a registered provider of training for immigration advisers. The CPD Standards Office is working in partnership with the Office of the Immigration Services Commissioner (OISC) to regulate immigration training. Tier 4 Seminar delegates will receive an official CPD certificate of completion that they can include in their CPD record. (more...)

### **16-19 sector**

Increasing numbers of enquiries are coming in to UK NARIC from schools and colleges about international GCSE equivalencies, as they attempt to satisfy new 16-19 funding rules requiring students to hold GCSEs in maths and English at grade C or better - or overseas equivalent.


UK NARIC advice on overseas qualifications is incorporated into new DfE funding arrangements for 16-19 education and we are named as the official information point.
