

In this session, our Platinum Sponsor LanguageCert will explore the growing need to develop students' oracy. The Oracy Education Commission describes oracy as 'articulating ideas, developing understanding and engaging with others through speaking, listening and communication.'

The benefits of oracy appear obvious, but the promotion of oracy in education at all levels is uneven. Higher Education faces a rise in the undetectable use of generative AI for coursework and written assessments. A possible solution is to complement written assessments with greater use of spoken assessments. This would, in turn, require students to verbally express their ideas and defend them in real time to a greater extent than before.

To prepare students for such demands, it is imperative that highstakes admissions tests not only assess spoken communicative ability and interactional competence but also help foster a range of oracy skills, including verbal reasoning and critical thinking. Our discussion hubs provide you with the opportunity to discuss core and current issues with others working in International Education. This session covers 'Changing Markets' and is an opportunity to share insight and reflect on some of the changes you may have seen in your role or at your organisation with student markets, facilitating you to talk through any challenges, any areas of concern, opportunities, and future considerations. Great expectations? How can you ensure the importance of having a common understanding of English language ability across your institution?

International students now make up over 23% of the UK's university student population (HESA, 2023)

However, a wide range of reports suggest that university staff find it increasingly difficult to understand the expectations they should have of the English level of these international students, how the students will be able to cope in class, complete their course, and indeed even integrate into the community while they are here.

In turn, staff may experience difficulties and frustration determining what and how much language support students require for academic study, and in setting the appropriate minimum required standardised English test score thresholds. This can lead to international students feeling isolated and unsupported, and/or not progressing, which can have a significant impact on their academic performance and wellbeing. It is important for university staff to both remain compliant and better understand the needs of international students and provide adequate support and guidance.

In an effort to de-mystify this area, we need to remain compliant, to unpick and better understand what these challenges are, why they are arising, who is involved in the process, who can provide support to the different groups, and ensure that all stakeholders – including admissions, compliance, English departments, senior management, recruitment and teaching staff - are armed with the necessary resources and training to navigate these complexities, and have a clear understanding of what is expected. This understanding will help create a more efficient university admission process and ensure that all stakeholders are on the same page. Additionally, it will provide students with a fair and transparent admissions process.





Hedd is frequently approached by prospective students keen to establish the bona fides of learning providers that don't have an obvious footprint in the sector. We have recently dealt with several cases where it wasn't possible to say yes, this is a legitimate higher education provider or no, this is a diploma mill.

The problem is a lack of transparency. How reliable are the accreditation claims made by these providers? How are their pathway qualifications delivered? Do they really have the connections with universities that they claim?

If it is difficult for sector practitioners to answer these questions, what must it be like for prospective international students? Do they really understand what they have signed up and paid for? Using examples from recent investigations, we will explore this opaque world and ignite a discussion on what the sector can do to help international students make sense of it all.
