2. What data will we collect?

When completing the survey, we will invite you to provide the following information:

- Name
- Organisation name, department and/or job title
- Country
- Contact details including email and/or telephone number

• Information and opinions relating to international collaboration between higher education institutions in Europe and the Levant (Jordan, Lebanon and Syria) as well as the education systems in the Levant.

3. How will we use your data?

Your personal data will be used to gather feedback and statistics on activities for international collaboration between higher education institutions in Europe and the Levant, and the education systems in that region. Your contact details may be used to contact you for further information and to invite you to participate in interviews and focus groups on the subject.

We will not use your data for the purposes of direct marketing unless you ask us to. We will not share your data with any third party for the purposes of direct marketing.

4. Who will we share the data with?

Your data will be collected and stored via a third-party survey management software provider called Survey Monkey.

You should be aware that Survey Monkey are based in the United States of America, and your data may be stored outside the UK and European Union.

5. Lawful basis for processing your data

6. How long will we hold your personal data for?

7. Your rights
